# DETR Encourages Employers and Third-Party Administrators (TPAs) to Sign Up in the New Nevada Unemployment Insurance (NUI) System

CARSON CITY, Nev. – The Nevada Department of Employment, Training and Rehabilitation (DETR) would like to remind employers that their **first quarterly filing is due on April 30, 2024.** Employers should go to <a href="mailto:nui.nv.gov/ess/">nui.nv.gov/ess/</a> to access the state's new and improved Nevada Unemployment Insurance Employer Self Service system (NUI ESS).

While the new system offers many enhancements and is user-friendly, DETR strongly recommends employers and/or TPAs signing up in the system early to avoid filing delays and/or late charges.

"We urge those who haven't already signed up, to do so," says DETR Director Christopher Sewell. "It is important that people do not leave this task to the last minute and are familiar with the requirements of the new site, before April 30."

Below are important updates about the new website:

- Prior logon credentials (username/password) will not work for the new website. During a first visit, people will sign up to create a new username and password to access their account.
- Video tutorials for NUI ESS are available at <a href="https://ui.nv.gov/openhouse/openhouse.htm">https://ui.nv.gov/openhouse/openhouse.htm</a>.
- Existing ACH payment channels will be available to use in NUI ESS for quarterly filings. Payment channels can be easily added or removed online.
- Account information back to 2016 will be available in NUI ESS.
- NUI ESS provides an online assistant (*Benny*) trained to answer many common employer questions.
- NUI ESS will run on most mobile devices and desktops/laptops regardless of their operating system.

### What employers will need:

- Employer Account Number
- Federal Employer Identification Number (FEIN)
- Quarterly Gross Wages from previous year

#### What TPA's will need:

- TPA Zip Code
- TPA Federal Employer Identification Number (FEIN)
- Up to 4 employer accounts which have been previously linked to the TPA
